# Regular Meeting, Open Session Minutes - Video Illinois Gaming Board Chicago, Illinois June 28, 2017

#### APPROVAL OF OPEN SESSION MINUTES:

Member Dunn moved that the Board approve the open session minutes from its Regular Meeting of May 25, 2017. Member Dolins seconded the motion. The motion passes unanimously by roll call vote.

#### TERMINAL OPERATORS

## **Initial Licenses**

Member Robinson seconded the motion. The motion passes unanimously by roll call vote.

## Failure to Respond to Administrator-Issued Disciplinary Complaint

Member Dolins moved the Board issue a Disciplinary Complaint revoking the terminal handler license of **William Aloysius Beckmann** for failing to disclose an arrest, and not responding to a Board issued Disciplinary Complaint, or paying a Board issued fine, said actions to take effect 21 days from the date of service of the Complaints, unless an Answer is properly filed within that timeframe. Member Dunn seconded the motion. The motion passes unanimously by roll call vote.

## Failure to Meet Minimum Qualifications for Licensure

Member Robinson moved the Board issue a Disciplinary Complaint revoking the establishment license of EATS & BEATS ENTERTAINMENT GROUP, INC. d/b/a JACKIE'S SLOTS & SHOTS for failing to notify the Board of the arrest and criminal conviction of its owner, said actions to take effect 21 days from the date of service of the Complaints, unless an Answer is properly filed within that timeframe. Member Dunn seconded the motion. The motion passes unanimously by roll call vote.

for failing to maintain the minimum qualifications for licensure, said actions to take effect 21 days from the date of service of the Complaints, unless an Answer is properly filed within that timeframe. Member Dolins seconded the motion. The motion passes unanimously by roll call vote.

Member Dolins moved that the Board issue a Disciplinary Complaint revoking the establishment license of **HORSESHOE SALOON**, **INC. d/b/a Horseshoe Saloon**, for its owner's interference with the approved and continuing operation of terminals in the

establishment, this action to take effect 21 days from the date of service of the Complaint, unless a \$1,000 fine is paid or an Answer is properly filed within that timeframe. Member Robinson seconded the motion. The motion passes unanimously by roll call vote.

## Failure to Prevent Underage Access to VGTs

Member Dolins moved that the Board issue Disciplinary Complaints **revoking** the retail establishment licenses of:

- 27 Irving Park, LLC d/b/a Horseshoe Inn
- THE BACK ROOM, INC. d/b/a Cafe Amici
- Anna's Cafe Place LLC d/b/a Anna's Cafe Place LLC (130706234)
- ELITE CAFE & BILLIARDS, INC. d/b/a ELITE BILLIARDS
- SIMONE CORP. d/b/a BELL LIQUOR & TAP

for permitting persons under the age of 21 to access, use or play video gaming terminals, said actions to take effect 21 days from the dates of service of the Complaints, unless the establishment pays a fine of \$5,000 or properly files an Answer within that timeframe. Member Dunn seconded the motion. The motion passes unanimously by roll call vote.

## **Failure to Provide Safe Gaming Location**

Member Dolins moved that the Board issue Disciplinary Complaints **revoking** the retail establishment licenses of:

- Club 30, LLC d/b/a Jag's Bar;
- Breakout Inc. d/b/a Breakout Billiards;
- DESPERADO BAR AND GRILL LLC d/b/a DESPERADO BAR AND GRILL LLC; and
- Mucho Gusto LLC d/b/a N-Zuri

for conducting video gaming operations in a manner that poses a threat to public health and safety; for reflecting adversely on the security and integrity of the video gaming industry in Illinois and/or employing persons of notorious and unsavory reputations; and otherwise failing to maintain the minimum qualifications for licensure, said actions to take effect 21 days from the dates of service of the Complaints, unless an Answer is properly filed within that timeframe. Member Robinson seconded the motion. The motion passes unanimously by roll call vote.

## Failure to Maintain Valid Liquor License

Member Dolins moved that the Board issue a Disciplinary Complaint **revoking** the retail establishment license of **Stacy`s 45**, **Incorporated d/b/a Stacy`s 45**, said actions to take effect 21 days from the date of service of the Complaint, unless an Answer is properly

filed within that timeframe. Member Robinson seconded the motion. The motion passes unanimously by roll call vote.

## **Associations with Persons with a Criminal History**

Member Dolins moved that the Board issue a Disciplinary Complaint **revoking** the retail establishment license of **LISA FRISBY ENTERPRISES**, **LLC d/b/a JAK'S GAMING CAFE**, due to the criminal history of a person of significant interest and control, said actions to take effect 21 days from the dates of service of the Complaints, unless an Answer is properly filed within that timeframe. Member Dunn seconded the motion. The motion passes unanimously by roll call vote.

## **Settlements of Disciplinary Complaints**

Member Dunn Based on staff's recommendation, as well as information provided by the licensee, I move that the Board rescind the Disciplinary Complaint voted by the Board to be issued at its May 2017 meeting to **Illinois Gaming Investors LLC**. Member Dolins seconded the motion. The motion passes unanimously by roll call vote.

Member Robinson moved to delegate to the Administrator the authority to enter into settlement agreements with, and to administratively dismiss the complaints against the following licensees or to provide the settlement agreements to the administrative law judge for disposition:
