# Regular Meeting, Open Session Minutes Illinois Gaming Board Chicago, Illinois January 30, 2020

The Illinois Gaming Board ("Board") convened for a Regular Meeting on Thursday, January 30, 2020 at approximately 9:04 A.M. in the Conference Room of the Gaming Board office on the 5th Floor of the Michael Bilandic Building, Chicago, IL pursuant to the Illinois Open Meetings Act, 5 ILCS 120/1 *et seq*.

A roll call was taken. The following Board members were physically present: Chairman Charles Schmadeke, Member Steve Dolins, Member Ruben Ramirez and Member Dionne Hayden. Four members of the Board being physically present, a quorum was satisfied.

At approximately 9:05 A.M., Member Dolins moved that the Board go into closed session pursuant to Section 2(c), paragraphs (11), (21) and (36) of the Open Meetings Act and Section 6(d) of the Illinois Gambling Act to discuss items on the closed session agenda relating to the closed session minutes and pending litigation. Member Hayden seconded the motion. The Board approved the motion unanimously by voice vote. Thereafter, the Board moved from the Conference Room on the 5th Floor of the Michael Bilandic Building to the Conference Room on the 3rd Floor of the building for a closed session meeting, the minutes of which are separately recorded.

At approximately 10:36 A.M., the Board returned to the Conference Room on the 5th Floor of the Michael Bilandic Building, in Chicago, Illinois to reconvene its Regular Meeting of Thursday, January 30, 2020 pursuant to the Illinois Open Meetings Act, 5 ILCS 120/1 *et seq*.

The following Board members were physically present: Chairman Charles Schmadeke, Member Steve Dolins, Member Ruben Ramirez and Member Dionne Hayden. Four members of the Board being physically present, a quorum was satisfied.

#### APPROVAL OF OPEN SESSION MINUTES

Member Ramirez moved that the Board approve the open session minutes from its Regular Meeting of Thursday, December 19, 2019. Member Hayden seconded the motion. The motion passed unanimously via voice vote.

Member Hayden moved that the Board approve the open session minutes from its Regular Meeting held on Thursday, November 7, 2019, as amended. Member Dolins seconded the motion. The motion passed unanimously via voice vote.

#### **CHAIRMAN COMMENTS**

The Chairman briefly noted that the IGB is immersed into gaming expansion and commended staff for the diligent and wise efforts they have taken in moving forward with this expansion.

## ADMINISTRATOR'S REPORT

Administrator Fruchter noted that 2019 was a productive year for the IGB and that 2020 is off to a productive start especially with the Board's efforts to implement gaming expansion. The Administrator provided a summary of the IGB's progress in the various gaming-related areas. With respect to sports wagering, he noted the Board released sports wagering applications and Phase 1 rules on December 19, 2019. On January 23, 2020, the Board released the Phase 2 rules for sports wagering. He also noted that the rules may be found on the Board's website and invited everyone to review them and comment if they wish. On the casino front, the Administrator reported that staff continues to review and process the new casino applications as well as the two racetrack casino applications along with its normal work in connection with the ten existing casino owners licenses. With respect to video gaming, the Administrator mentioned that the Joint Committee on Administrative Rules (JCAR) decided in December to allow certain proposed IGB rules to become effective which allowed the IGB to implement the 6th VGT at licensed location establishments. As of the end of January 2020, there are 896 locations with an operational 6th VGT while 2,320 additional locations have been approved for the 6th VGT. The IGB has 216 requests for a 6<sup>th</sup> VGT that remain pending. Administrator Fruchter alluded to the fact that 5 large truck stop applications would soon be approved by the Board which are the first in that category to be licensed. He also mentioned that the G2S conversion was fully completed on December 20, 2019 and that the Board has worked diligently to approve software upgrades that would allow the maximum bet and jackpots to be raised. The Administrator noted that there are 7,212 licensed locations operating 34.076 VGTs.

The Administrator stated that earlier in the month, the Gaming Board became aware of a possible unauthorized disclosure of licensees' personal information by an IGB employee to individuals at three Government entities. The Administrator went on to say that the IGB values its licensees' personal information and takes its statutory obligations seriously and are committed to protecting the confidentiality of IGB records. Accordingly the IGB will take appropriate action when such data protection and confidentiality laws and rules are violated. Upon learning of this matter, the IGB commenced an immediate investigation, which is on-going and placed the employee on paid administrative leave, pending the completion of the investigation and related personnel processes. The IGB has complied with and is complying with its obligations under the Illinois Information Protection Act. The IGB notified the General Assembly and sent notices yesterday by certified mail to the individuals affected by the situation. The IGB is acting in a transparent manner, yet we are limited by what we can share at this time, due to the on-going investigation and the internal personnel processes that we have to follow.

The Administrator acknowledged and commended Gaming Unit Supervisor Jeff Gaida who is retiring after many years of distinguished service. He thanked Jeff for his outstanding work and wished him good luck in the future. Finally, Administrator Fruchter extended his sympathies to the family and friends of retired Illinois State Trooper Gregory Rieves who was a recent victim in a tragic shooting.

Member Ramirez moved that the Board adopt the Administrative Law Judge's recommendations in 18 GB 057 In Re: Fill-Up Mart, Inc. d/b/a Fill-Up Mart #12 and issue a final Board order of denial. Member Hayden seconded the motion. The motion passed unanimously via voice vote.

Member Dolins moved that the Board adopt the Administrative Law Judge's findings of fact and recommended decision, except to any fact or conclusion that suggests that a licensee is not subject to revocation for a single instance of illegal gambling, and issue a final Board order suspending Jeffrey Haines' license for two years. Member Ramirez seconded the motion. The motion passed unanimously via voice vote.
