Regular Meeting, Open Session Minutes Illinois Gaming Board Chicago, Illinois February 8, 2024

The Illinois Gaming Board convened for a Regular Meeting on Thursday, February 8, 2024, at 9:00 A.M. in the 5th Floor Auditorium of the of the Michael A. Bilandic Building, 160 N. LaSalle Street, Chicago, IL, and through electronic means pursuant to the Illinois Open Meetings Act, 5 ILCS 120/1 *et seq*. The meeting was accessible on the morning of February 8, 2024, via livestream at: https://multimedia.illinois.gov/igb/igb-live.html.

A roll call was taken. The following Board members were physically present: Chairman Charles Schmadeke, Member Dionne Hayden and Member James Kolar. Three members of the Board being present, a quorum was satisfied.

At approximately 9:01 A.M., Member Kolar moved to go into closed session pursuant to Section 2(c), paragraphs (1), (4), (11), (21) and (36) of the Open Meetings Act and Section 6(d) of the Illinois Gambling Act to discuss items on the closed session agenda relating to the employment and performance of a specific employee, pending litigation, the review of closed session minutes of the Regular Board Meetings, and to deliberate on decisions of the Illinois Gaming Board in which there is discussed personal, commercial, financial, or other information obtained from any source that is privileged, proprietary, confidential, or a trade secret; or information specifically exempted from the disclosure by federal or State law. Member Hayden seconded the motion. The Board approved the motion unanimously by voice vote. Thereafter, the Board held its closed session meeting in person and through electronic means, the minutes of which are separately recorded. The Board's closed session meeting was not accessible via livestream at https://multimedia.illinois.gov/igb/igb-live.html.

At approximately 10:50 A.M., the Board reconvened its Regular Meeting of Thursday, February 8, 2024, pursuant to the Illinois Open Meetings Act, 5 ILCS 120/1 *et seq*. The meeting was held in person and through electronic means. The meeting was accessible on the morning of February 8, 2024 via livestream at: https://multimedia.illinois.gov/igb/igb-live.html.

Another roll call was taken. The following Board members were present: Chairman Charles Schmadeke, Member Dionne Hayden and Member James Kolar. Three members of the Board being present, a quorum was satisfied.

BOARD MEMBER COMMENTS

ADMINISTRATOR'S REPORT

Administrator Fruchter began the meeting by noting that the Super Bowl is on Sunday, February 11, 2024 which heightens awareness of the need for responsible gaming measures. He advised people to stay within their limits and only use licensed Illinois operators when making wagers. Administrator Fruchter mentioned several resources that are available to those seeking help with problem gambling. He also explained that certain kinds of "prop bets" are legal for Illinois sports wagering operators to offer while others are not.

Administrator Fruchter noted that as of today, Illinois has 15 casinos, 13 sportsbooks, 57 active Terminal Operators, 8,443 licensed Establishments and 47,014 video gaming terminals ("VGTs"). In December, Illinois VGTs generated Net Terminal Income (("NTI") of \$250,905,997, which produced a State tax of \$72,766,024 and local tax of \$12,540,893. Illinois' casinos had Adjusted Gross Receipts ("AGR") of \$141,227,205, which resulted in State tax of \$37,810,380 and local tax of \$8,491,196. Sports wagering had AGR of \$128,430,319, resulting in State tax of \$19,264,547 and Cook County tax of \$1,252,546. In 2023, Illinois generated \$1,550,367,441 of gaming tax revenue. The State received \$1,307,113,715, while local communities received \$243,253,726.

In January 2024, VGTs had NTI of 221,171,692, which produced 64,142,000 in State tax and 11,056,478 in local tax. Casinos had AGR of 118,642,379 which resulted in State tax of 13,582,335 and local tax of 7,168,464.

APPROVAL OF MINUTES

The Board voted unanimously to approve the minutes from its Regular Meeting held on December 7, 2023.

The Board voted unanimously to adopt the staff's recommendation to find that the need for confidentiality still exists for the closed session minutes of the Board's Closed Session meetings in 2023 along with all other closed session minutes not yet approved by the Board for dissemination.

ADMINISTRATIVE MATTERS

Rule 1900.1130 Request - Major League Soccer

The Board voted unanimously to adopt the staff's recommendation to issue an Order prohibiting sports wagering on the issuance of yellow and red cards in all soccer matches.

Board Resolution to Extend Existing Resolution and to Amend to Allow the Administrator to approve authorized games for play by an Owners licensee under Section 3000.605 of the Board's Rules

The Board voted unanimously to adopt the staff's recommendation to renew the existing February 9, 2023 Board Resolution to Delegate Certain Authority to the Administrator and have it remain in effect until the first regular Board meeting of the 2025 calendar year, unless modified by the Board.
