**Jumer's Casino & Hotel is located at the intersection of I-280 and IL Hwy 92 in Rock Island, Illinois. Situated on a 118 acre site, Jumer's Casino & Hotel consists of a 42,500 square foot gaming floor with 1069 electronic gaming devices and 22 table games. The casino also has a high limit slot room and a live poker room with 6 tables.**

**In addition to gaming, adjacent to the casino floor is a nightclub.**

**The 205 room hotel includes 11 luxury suites, an indoor pool, fitness center, gift shop and a salon and day spa.**

**There are four restaurants at Jumer's. A deli, buffet, casual dining and a top end steak and seafood restaurant.**

**Parking for the facility is provided by a two level parking deck for 460 and surface level parking that can accommodate 1200 vehicles.**

**Jumer's Event Center is a multi-purpose facility that is used for entertainment offerings, meetings, conventions, wedding receptions and banquet events.**
