

Jumer's Casino & Hotel is located at the intersection of I-280 and IL Hwy 92 in Rock Island, Illinois. Situated on a 118 acre site, Jumer's Casino & Hotel consists of a 42,300 square foot gaming floor with 1001 electronic gaming devices and 22 table games. The casino also has a high limit slot room and a live poker room with 6 tables.

In addition to gaming, adjacent to the casino floor is a nightclub.

The 205 room hotel includes 11 luxury suites, an indoor pool, fitness center, aqua driving range and a salon and day spa.

There are four restaurants at Jumer's. A deli, buffet, casual dining and a top-end steak and seafood restaurant.

Parking for the facility is provided by a two level parking deck for 460 and surface level parking that can accommodate 1200 vehicles.

Jumer's Event Center is a multi-purpose facility that is used for entertainment offerings, meetings, conventions, wedding receptions and banquet events.

For year 2015, admissions were 1,034,726 a decrease of 39,704 from 2014.

A.G.R. for year 2015 was \$76,710,000 an increase of \$54,226 compared to 2014.
