**Jumer's Casino & Hotel is located at the intersection of I-280 and IL Hwy 92 in Rock Island, Illinois. Situated on a 118 acre site, Jumer's Casino & Hotel consists of a 39,604 square foot gaming floor with 869 electronic gaming devices and 19 table games. The casino also has a high limit slot room and a live poker room with 6 tables.**

**In addition to gaming, adjacent to the casino floor is a nightclub.**

**The 205 room hotel includes 11 luxury suites, an indoor pool, fitness center, aqua driving range, patio with fire pit and a boardroom for meeting space rental.**

**There are four restaurants at Jumer's. A deli, buffet, casual dining and a casual steakhouse restaurant.**

**Parking for the facility is provided by a two level parking deck for 460 and surface level parking that can accommodate 1200 vehicles.**

**Jumer's Event Center is a multi-purpose facility that is used for entertainment offerings, meetings, conventions, wedding receptions and banquet events.**

**The efforts above were utilized pre-pandemic (Jan-Mar). We paused our hiring during the closures due to the pandemic.**

**Currently, we employ 348 team members with 180 active associates and 168 suspended on furlough. We expect to bring our furloughed associates back to active status throughout the 2021 calendar year as the Covid-19 situation improves. As business volumes return to pre-pandemic levels, our hope would be to increase our staffing back to around 400 associates.**

**For year 2020, admissions were 292,390 a decrease of 556,986 from 2019.**

**A.G.R. for year 2020 was \$24,007,014 a decrease of \$42,308,200 compared to 2019.**
