Gaming Board Releases Available Super Bowl Sports Wagering Data

CHICAGO – Based on information available to the Gaming Board from Illinois sports wagering operators as of the date of this release, the preliminary sports wagering handle and adjusted gross receipts (“AGR”) for Super Bowl LVI on February 13, 2022 are as follows:
