Regular Meeting, Open Session Minutes Illinois Gaming Board Chicago, Illinois June 6, 2024

The Illinois Gaming Board convened for a Regular Meeting on Thursday, June 6, 2024, at 9:00 A.M. in the 5th Floor Auditorium of the Michael A. Bilandic Building, 160 N. LaSalle Street, Chicago, IL, and through electronic means pursuant to the Illinois Open Meetings Act, 5 ILCS 120/1 *et seq*. The meeting was accessible on the morning of June 6, 2024, via livestream at: https://multimedia.illinois.gov/igb/igb-live.html.

A roll call was taken. The following Board members were physically present: Chairman Charles Schmadeke, Member Anthony Garcia and Member Dionne Hayden. Member James Kolar was present and participated in the meeting through electronic means. Four members of the Board being present, a quorum was satisfied.

At approximately 9:01 A.M., Member Garcia moved to go into closed session pursuant to Section 2(c), paragraphs (1), (4), (11), (21) and (36) of the Open Meetings Act and Section 6(d) of the Illinois Gambling Act to discuss items on the closed session agenda relating to the employment and performance of a specific employee, pending litigation, the review of closed session minutes of the Regular Board Meetings, and to deliberate on decisions of the Illinois Gaming Board in which there is discussed personal, commercial, financial, or other information obtained from any source that is privileged, proprietary, confidential, or a trade secret; or information specifically exempted from the disclosure by federal or State law. Member Hayden seconded the motion. The Board approved the motion unanimously by voice vote. Thereafter, the Board held its closed session meeting in person and through electronic means, the minutes of which are separately recorded. The Board's closed session meeting was not accessible via livestream at https://multimedia.illinois.gov/igb/igb-live.html.

At approximately 10:00 A.M., the Board reconvened its Regular Meeting of Thursday, June 6, 2024, pursuant to the Illinois Open Meetings Act, 5 ILCS 120/1 *et seq*. The meeting was held in person and through electronic means. The meeting was accessible on the morning of June 6, 2024 via livestream at: https://multimedia.illinois.gov/igb/igb-live.html.

Another roll call was taken. The following Board members were physically present: Chairman Charles Schmadeke, Member Anthony Garcia and Member Dionne Hayden. Member James Kolar was present and participated in the meeting through electronic means. Four members of the Board being present, a quorum was satisfied.

APPROVAL OF MINUTES

The Board voted unanimously to approve the minutes from its Regular Meeting held on April 25, 2024.

BOARD MEMBER COMMENTS

ADMINISTRATOR'S REPORT

Administrator Fruchter began his report by acknowledging that today (June 6, 2024) marked the 80th anniversary of the D-Day invasion by the Allies on Normandy Beach, an incredibly important moment in world history that should not be forgotten.

The Administrator announced that a Request for Proposals ("RFP") relating to the Central Communication System ("CCS") for video gaming terminals ("VGTs") was recently posted on the State of Illinois's procurement website. He noted that the CCS is currently being operated under a bridge contract that followed the original 10-year CCS agreement. Illinois is seeking bids from vendors to operate the CCS after the current bridge contract expires. The new contract will be for 5 years, with two potential renewals of 3 years and 2 years, respectively. Responses to the RFP are due on August 5, 2024.

Next, Administrator Fruchter provided a brief update regarding gaming-related measures that were passed during the most recent spring legislative session, which included changes to the tax rates for sports wagering and video gaming as well as an extension of the casino construction tax credit. The Administrator further noted that the end of the legislative session also brought about a prohibition regarding wagering on events involving Illinois collegiate teams after July 1, 2024.

Administrator Fruchter noted that Illinois has 15 operating casinos, 14 sportsbooks (13 of which are open and operating) and 61 Terminal Operators. He further noted that there are 8,528 licensed establishments operating a total of 48,199 video gaming terminals ("VGTs") of which 47,855 have the \$4 max bet software and more than five VGTs are present in 6,209 licensed establishments.

In April, Illinois' VGTs generated net terminal income ("NTI") of \$257,314,667, which resulted in a total tax of \$87,486,939. The State received \$74,625,588 while local municipalities received \$12,861,351. In the same period, Illinois' casinos produced adjusted gross receipts ("AGR") of \$136,997,283, which produced a total tax of \$31,523,261. The State received \$23,210,030, while host communities received \$8,313,231. In March, sports wagering produced AGR of \$99,420,016, which generated tax of \$16,006,616. The State received \$14,913,002, while Cook County received \$1,093,614. Between January 1, 2024 and April 30, 2024 (but only March for sportsbooks), Illinois' gaming segments have generated a total tax of \$501, 710, 134 with the State retaining \$415,351,862 and host communities retaining \$86, 358,272.

Administrator Fruchter closed his report by encouraging anyone to visit the IGB's website and the Prohibited Conduct Reporting portal to report potential unlawful activity involving alleged violations of casino, video gaming or sports wagering laws or rules or other misconduct by IGB licensees or applicants.
